

## **Additional information regarding attendance to the shareholders meeting**

### **Right to attend and vote at the meeting (other than nominee registered)**

In order to attend and have a right to vote at the Annual General Meeting of Konecranes on March 27, 2025, a shareholder must:

- a) be registered in the shareholders' register of Konecranes Plc, held by Euroclear Finland Ltd, on the record date Monday, March 17, 2025; and
- b) give a prior notice of participation no later than on Thursday, March 20, 2025 at 4.00 p.m. (Finnish time).

Changes in shareholdings after the record date of the General Meeting do not affect the right to participate in the General Meeting or the shareholder's voting rights at the General Meeting.

### **Nominee registered shareholders**

Nominee registered shareholders, i.e. shareholders who are holding their shares under the name of a broker, custodian bank or other nominee ("Custodian"), should take the following steps to have a right to vote at the Annual General Meeting 2025.

- 1) Please contact your Custodian without delay and request necessary instructions regarding the registration in the shareholders' register, the issuing of proxy documents and registration for the Annual General Meeting.**

Shareholders, who hold their shares under a name of a nominee, can temporarily be registered in the Register of Shareholders in order to attend the Meeting. To be able to be registered temporarily in the Register of Shareholders

- a) a shareholder must have the right to be registered, on the basis of his/her shareholdings, to the Register of Shareholders on the record date Monday, March 17, 2025; and
- b) the Custodian must give a notice of registration no later than on Monday, March 24 at 10.00 a.m. (Finnish time).

Nominee registered shareholders may be recorded in the Konecranes' Register of Shareholders temporarily only for purpose of taking part and voting at the Meeting.

Changes in shareholdings after the record date of the General Meeting (March 17, 2025) do not affect the right to participate in the General Meeting or the shareholder's voting rights at the General Meeting.

- 2) **Please instruct your own Custodian to affect the temporary recording in the Register of Shareholders of Konecranes. The Custodian shall give a notice of registration for temporary registration in the Register of Shareholders no later than on Monday, March 24 at 10.00 a.m. (Finnish time)**

A notification by a holder of nominee-registered shares for temporary inclusion in the Company's shareholders' register is understood as prior notice of participation in a General Meeting.

- 3) **Follow the instructions of your own Custodian**

### **Proxies**

If you wish to be represented by your Custodian at the General Meeting, please contact your Custodian for further instructions.

You may also be represented by some other person than your Custodian. In that case a proxy representative shall produce a dated power of attorney.

When a shareholder participates in the General Meeting by means of several proxy representatives representing the shareholder with shares at different securities accounts, the shares by which each proxy representative represents the shareholder shall be identified in connection with the registration for the General Meeting.
