Roadshows and events during the quarter

During the first quarter after our Q4 results, we organized roadshows in London with DNB, as well as on the US East Coast and in Toronto with Handelsbanken. In addition, we participated in Carnegie's Nordic Capital Goods seminar in Stockholm, held group investor meetings hosted by analysts and discussed with investors on many individual 1-1 calls and meetings.

During the quarter, the most frequent discussion topics have included: market environment, demand outlook and financial guidance, delivery capability and order lead times, supply chain constraints and component shortages, cost inflation and pricing, Group and segment margin development, cash flow and net working capital development, new CEO's first impressions on the company, upcoming Capital Markets Day and the strategy review process, optimization of Business Area Industrial Service and Equipment's operations, and sustainability.
